Civil Support/Security Specialist Military Occupational Specialty Management

Summary. This regulation prescribes the policies, procedures, and curriculum for initial appointment, training, and career management of the Civil Support/Security (CSS) Specialist Military Occupational Specialty (MOS) within the Virginia Defense Force (VDF).

Applicability. This regulation applies to the units of the VDF. During mobilization for state active duty, procedures in this publication can be modified to support policy changes as necessary.

Suggested Improvements. Users are invited to send comments and suggested improvements directly to Headquarters, Virginia Defense Force, Attention: G-1, 5001 Waller Road, Richmond, Virginia 23230-2915.

Proponent and exception authority. The proponent and exception authority is the VDF Commanding General (CG). Any revisions or exceptions to this regulation are prohibited without prior written approval from the VDF CG.

Distribution. Distribution is intended for all VDF units down to the Company level.

Chapter 1 General Provisions

1-1. Purpose and Authority

This VDF Regulation (VDFR) 611-1 prescribes the policies, procedures, and curriculum for initial appointment, training, and career management of the Civil Support/Security Specialist Military Occupational Specialty within the Virginia Defense Force. This regulation is to be read and interpreted as a stand-alone document. If any provisions of another military service regulation/instruction/order conflict with any provision herein, the provisions of VDFR 611-1 are controlling, except to the extent that it conflicts with controlling statutory or regulatory law.

1-2. References

Required and related publications are listed in Appendix A.

1-3. Policy

The Virginia Department of Military Affairs (DMA) requires VDF personnel to be trained and deployable during exercises or emergent situations to support civil organizations, as representatives of the Joint Staff Headquarters' (JFHQ), Joint Operations Center (JOC), and when deployed with Virginia National Guard (VANG) units across the Commonwealth. Due to resource constraints and operational tempo, The Adjutant General (TAG) of Virginia has established a continuing requirement for the VDF to augment VANG capabilities within the range of civil support capabilities, specifically described in the referenced JFHQ Playbook. Accordingly, the VDF will establish a CSS MOS to answer the mission needs. This Directive will prescribe the CSS MOS proficiency levels and qualifications.

1-4. Mission Essential Task List and Mission Descriptions

The TAG has directed that VDF provide security and civil support capabilities per the references and specifically as outlined in the National Guard Civil Support (NGCS) Playbook. VDF will develop civil support competencies so as to support related missions assigned by the JFHQ.

a. Mission Essential Task List (METL).

- (1) Provide the VDF Civil Support/Security MOS Level 2-qualified Soldiers.
- (2) Ensure Soldiers are properly trained to applicable NGCS Playbook missions and prepared for assignment to a National Guard Support Team (NGST).
- (3) Train to proficiency for protecting people and property across the Commonwealth of Virginia during man-made and natural disasters.
- b. <u>Liaison Function</u>. Qualified Liaison Officers (LNO) may be assigned by the JFHQ/JOC to Virginia's Regional Emergency Operations Centers (EOCs) as Regional Liaison Resources or

as Emergency Support Function (ESF) -16 personnel supporting the Virginia Department of Emergency Management (VDEM). LNOs may as well be sent to a staging area or other location as needed to represent the JOC or a VANG unit assigned to a civil support mission.

- c. <u>General Civil Support</u>. The TAG has directed that VDF further provide general civil support capabilities as outlined in the NGCS Playbook, including:
 - (1) Operate Statewide Agencies Radio System (STARS) Radios
 - (2) Support Emergency Water, Food, Clothing, and Medical Distribution Points
 - (3) Support evacuation and rescue of civilians from an affected area
 - (4) Conduct Damage Reconnaissance
 - (5) Assist in Light Urban Search and Rescue
 - (6) Conduct Wilderness Search and Rescue
 - (7) Assist in Road Clearing Operations
 - (8) Conduct Interior and Exterior Guard Operations
- (9) Conduct Access Control Operations (Control Entry and Exit from a Restricted Area; Perform Gate Sentry Duty; Support Roadblock Operations; Conduct Traffic Control Operations)

Chapter 2

Proficiency Levels

2-1. Policy

CSS Specialists must achieve and maintain MOS proficiency enough to instantly perform in the complex mixed mission environment outlined in Chapter 1. Therefore, CSS Specialists will train to standard on civil support-related mission essential tasks. These essential tasks or training requirements will correspond to different levels of increasing proficiencies, which are described further below.

2-2. Tactics, Techniques, and Procedures

Due to their unique background, roles, and missions, the CSS MOS proficiency will be based on a combination of military, Federal Emergency Management Agency (FEMA) and American Red Cross (ARC) proficiencies, but with more of a security and civil support focus. Much of the CSS training curriculum is derived from identified state agencies, Civil Air Patrol (CAP), FEMA Emergency Management Institute (EMI), FEMA's Community Emergency Response Team (CERT) curriculums, and may be augmented by relevant ARC courses. All CSS specialists must meet General and Professional Military Education (PME) qualifications in addition to MOS Level criteria to be considered for MOS certification, as outlined in Appendixes D to G.

2-3. CSS MOS Level 1 (Basic)

CSS MOS Level 1 qualification will be attained by completing the requirements listed in Appendix D.

2-4. CSS MOS Level 2 (Senior)

CSS MOS Level 2 qualification will be attained by completing the requirements listed in Appendix E. Upon successful MOS qualification (MOSQ), the soldier will be awarded the VDF Mission Qualification Ribbon (MQR) in accordance with VDF Regulation 600-8-22.

2-5. CSS MOS Level 3 (Master)

CSS MOS Level 3 qualification will be attained by completing the requirements listed in Appendix F. Upon successful MOSQ, the soldier will be awarded the silver dogwood blossom for the VDF Mission Qualification Ribbon (MQR) in accordance with VDF Regulation 600-8-22.

2-6. CSS MOS Level 4 (Specialties)

CSS MOS Level 4 qualification will be limited to designated specialties developed between the JFHQ J3 and VDF. VDF may offer some related training, and other specialties will be achieved and maintained outside VDF training cycles. The current list of specialties is contained in Appendix G.

2-7. Reporting

The G3 CSS MOS Manager will schedule, plan, and manage CSS training as shown in the appendices in accordance with (IAW) the Yearly Training Plan (YTP) and Major Subordinate Command (MSC) S3 documentation. Certification will operate generally on a two-year cycle. Certification and deplorability will be required for membered on relevant National Guard Support Teams (NGST)

2-8. Readiness Certification

In order to ensure that all levels of VDF command have cognizance of who has met all training requirements the following applies:

- a. Training currency in all courses will be electronically maintained. The VDF G3 CSS MOS Manager will maintain a certified roster of all members who have met training standards and are ready to receive an assignment commensurate with their certification level.
- b. In cases of emergency need (i.e. Commonwealth or National emergency), deviations may be considered by CG on an individual basis. Individuals with a high level of previous demonstrated performance may receive a training waiver based on VDF needs. Deficient training should be provided to the extent possible and as time allows.

All soldiers assigned duties as a VDF CSS Specialist must meet the following minimum requirements:

- * Member in good standing of the VDF.
- * Possess a valid State driver's license or Commonwealth-issued identification card and submit a copy to keep on record.
- * Have no felony convictions by any civilian or military court.
- * Annually meet weight/height standards in accordance with VDF regulations.
